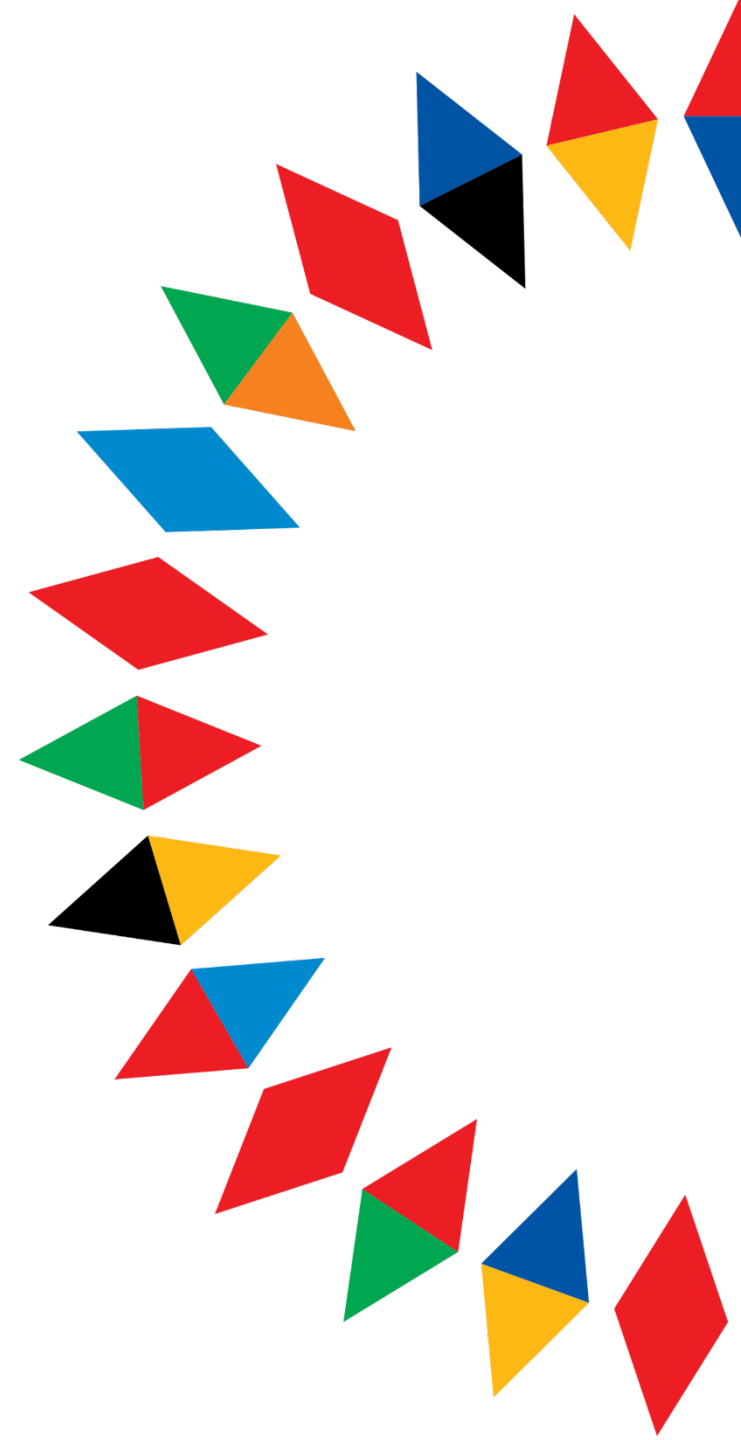

# Situation in the Czech Republic

- 11. 11. 22 – **457 727** temporary protections granted
  - Competence: Min. of Interior, Police
  - Need for rapid legislation changes in rapid legislation process– original law on Temporary protection transposing Directive 2001/55/EC not sufficient and realistic –new law „lex Ukraine“ package: immigration + state accommodation+ health care + labour market + social security+schools – regular amendments.
- \* Registration „one stop shops“ – one center in every region



# Rights attached

- Access to employment - free
- Accommodation – own/commercial/solidarity housing/state/other (NGOs)
- Social welfare – special new type of financial allowance (app. 192 eur)
- Medical care – full and free up to 150 days, then – certain categories – full but paid (app. 100 eur per month)
- Education – full, special rules due to capacity

# Form of temporary protection

Residence permit

- Visa sticker – type of „D“ visa (stays over 90 days)
- Number of entries „multi“ – possibility to travel within and outside of Schengen area
- Labeled as „D/DO/xxx“ to clearly identify
- Sticked into the travel document or not
- Record/stamp – for some period of time - lack of visa stickers, capacity problems
- Issued on the spot
- Visa only until 31. 3. 2023

# Main challenges related to reception

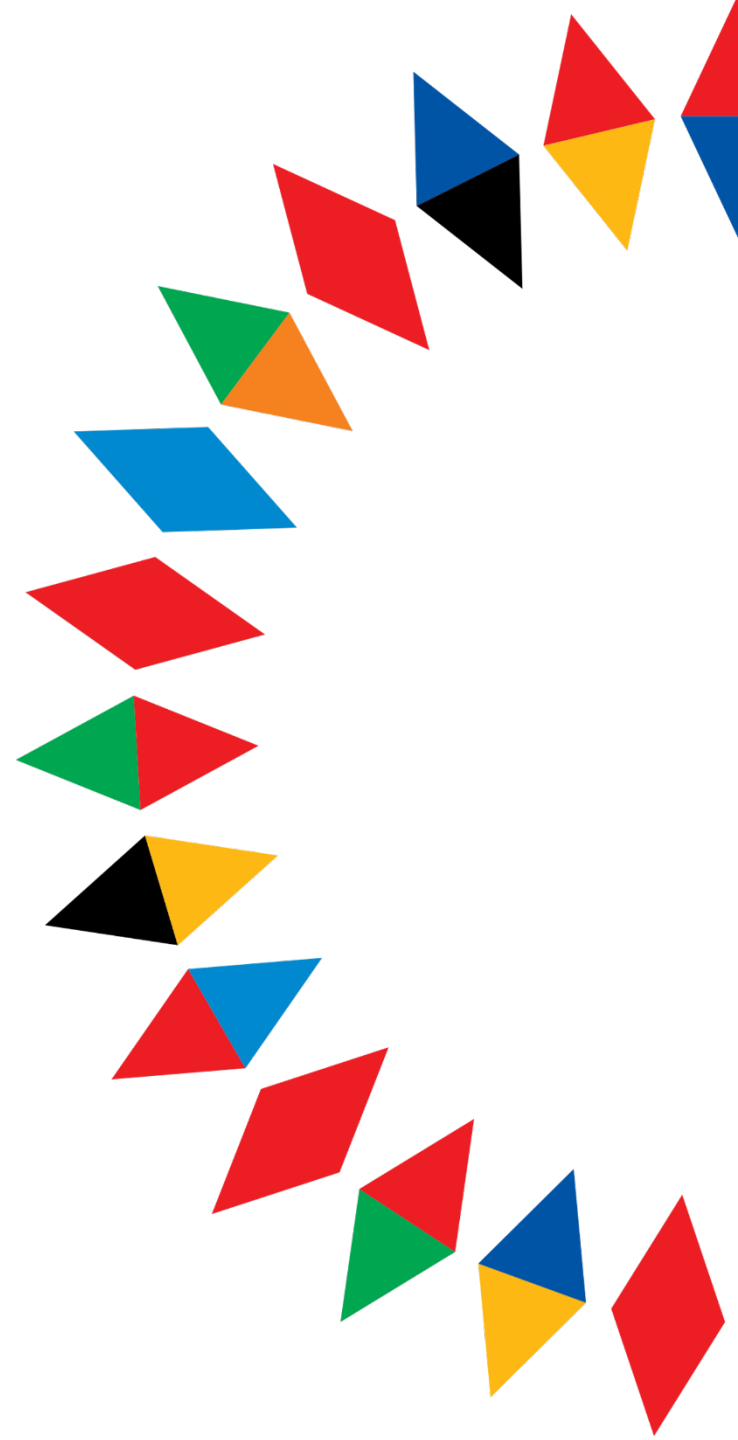
- Data collection and data Exchange – interoperability of national databases and systems
- CAPACITIES – state (Police, MOI, labour offices, regions ...), NGOs
- Access to commercial housing
- Children accompanied by non-parents + lack of capacities of Child Protection Offices
- Lack of documents – new cooperation with UKR established
- Unequal distribution among regions: problems with access to pediatric and psychological care, schools (all levels)
- Education system
- Lack of subsequent information on stay/leaving
- Preparation of prolongation – IT solution  
→ Extremely costly
