Speaker biographies

Panel I: The protection of Ukrainian refugees: the institutional perspective

<u>Cecilia VERKLEIJ</u>, Deputy Head of Unit, Asylum, DG Migration and Home Affairs, European Commission

Cecilia joined the Directorate General for Justice, Freedom and Security (now DG Migration and Home Affairs) in 2005. She previously worked on facilitating access to information for law enforcement authorities and agencies within the EU, with the aim of preventing and combatting terrorism and other forms of serious crime. She is currently deputy head of unit of the Asylum in DG HOME.

Nataša Chmelíčková, Czech Presidency of the Council of the EU

Natasa Chmelickova is head of unit for Asylum Legislation within the Ministry of the Interior of the Czech Republic. Currently she is a member of the legislation team dealing with temporary protection at national level. She also acts as a chair of the Asylum Working Party during the current Czech Presidency. She has been participating in negotiations related to the Common European Asylum System, including return legislation since 2007.

Lucie Verachten, General Secretariat of the Council

Lucie Verachten is a political administrator at the Justice and Home Affairs Directorate, dealing with migration. In 2013, she started working at the General Secretariat of the Council of the European Union, and since 2021 has been working in the JHA directorate. Previously, she was an archivist at the Belgian State Archives.

Giuseppe Varacalli, Committee of the Regions

Giuseppe Varacalli was the rapporteur on the European Commission's package Legal Migration - Attracting Skills and Talent to the EU. He is a member of the Gerace municipal council in Italy, an alternate member of the European Committee of the Regions, a member of the National Council of Anci (National Association of Italian Municipalities) and member of the ANCI regional council for the Calabria Region.

Panel II: The view from the ground: the challenges and strains facing refugees

<u>Justyna Segeš Frelak and Caitlin Katsiaficas</u>, International Centre for Migration Policy Development (ICMPD)

Justyna Segeš Frelak is a senior policy advisor for Legal Migration and Integration at ICMPD. She works on labour migration, migration governance and integration. From 2004 to 2017 she was working at the Institute of Public Affairs (Poland) as the head of the Migration Program and senior analyst. At her previous work, she focused on migration policy development, intra-EU mobility, integration of migrants and refugees in Poland and discrimination.

Gabriela Alexandrescu specialises in sociology with studies in management, economics and international humanitarian law. She has spent the last 20 years dedicated to advocating children's rights in the national and international fora.

Maria Papaioannou is an information and analysis officer and coordinates *inter alia* the EUAA Situational Updates System portfolio.
