He was a Bloomberg TV financial reporter based in Brussels and Berlin, and a CNN correspondent based in Germany and the White House. He reported for the Associated Press based in Paris, New York and Nashville. He's also a media consultant, media trainer and video producer, and has moderated panels for the World Economic Forum, OECD, OSCE, United Nations, World

Bank, EU institutions, NGOs and the private sector. He graduated in Political Economy at the University of California, Berkeley, and did post-grad studies in Europe.

# Oliver Röpke, EESC President



Oliver Röpke was elected as the president of the EESC in April 2023. Member of EESC since 2009, Mr Röpke was the president of the EESC Workers' Group, a member of the EESC Bureau and rapporteur of many EESC resolutions and opinions on employment and social policy, single market and innovation.

Mr Röpke headed the Brussels office of the Austrian Trade Union Federation (ÖGB) and took on several senior positions including as ÖGB representative to the EU institutions, the Executive Committee of the ETUC, and an advisory member of the ÖGB federal executive board. Mr

Pietro Francesco De Lotto, President of Consultative Commission on Industrial Change (CCMI)



Pietro Francesco De Lotto is the President of the Consultative Commission on Industrial Change (CCMI). The CCMI is coordinating the EESC flagship initiative Call for an EU Blue Deal. As the EESC Blue Deal coordinator, he recently signed the EESC-EP joint letter to the EU Heads of State and Government calling for an EU Blue Deal.

He was a Senior Researcher and Aggregate Professor in International Economics at the University of Trieste until 2009, when he moved to the private sector. In 2010, he was appointed to the EESC Employers' Group. Mr De Lotto was also President of the Eastern Neighbourhood Follow-up Committee and spokesperson for the SME category.

Mr De Lotto is the Founder and Director of Digital Innovation Hub. He was appointed Director General of Confartigianato, Italy's main SME association, and headed several leading companies as CEO/DG. He currently represents Confartigianato Imprese, the largest and leading national SME association.



Kinga Joó, Member of the EESC and rapporteur on the Blue Deal

Kinga Joó is a member of the European Economic and Social Committee since 2010. She is active in the work of the EESC's sections on Employment, Social Affairs and Citizenship (SOC) and Transport, Energy, Infrastructure and Information Society (TEN). Her background is in social and civil society organisations in Hungary. She is chairing the Social Responsibility board of the National Civil Cooperation Fund since 2020, where she has been a board member during the last three terms. She is also the international coordinator of the largest family organisation in Hungary, the National Association of Large Families (NOE).

As an EESC member working on the EU Blue Deal, she was a co-rapporteur of the opinions A Call for an EU Blue Deal (umbrella opinion <u>CCMI/209</u>) as well as a rapporteur on the opinion on Access to water: tackling water poverty and its implications for social policy (<u>SOC/763</u>).

# Pedro Arrojo Agudo, UN Special Rapporteur on the right to water and sanitation



Mr. Pedro Arrojo-Agudo is the Special Rapporteur on the human rights to safe drinking water and sanitation. He was appointed by the Human Rights Council in September 2020 and started his mandate on 1 November 2020. Previously, from 2016 to 2019, Arrojo-Agudo served as an elected member (MP) of the Spanish Parliament during its eleventh and twelfth legislature, during which he was part of the International Cooperation Committee working on human rights. Arrojo-Agudo was Professor in the Area of Fundamentals of Economic Analysis at the University of Zaragoza (1989-2011). He is the co-founder of New Water Culture Foundation and the Public Water Network (as part of Aqua Publica Europea).

#### Hasmik Barseghyan, President of European Youth Parliament for Water



Mrs. Hasmik Barseghyan is the President of the European Youth Parliament for Water (EYPW), with eight years' experience in project management and advocacy in the water, energy and environmental management sectors. Founded by the International Secretariat for Water, the EYPW has empowered thousands of young people to take action to protect our future and continues to drive ambition for greater inclusion of youth in decision-making processes.

As a water and climate action advocate, Hasmik brings the voice of youth to high-level European and international platforms. She was an official delegate to the COP26 in Glasgow, UK, as well as at the COP27

in Sharm-el-Sheikh, Egypt. She carried the voice of the Global Youth Movement for Water to the UN2023 Water Conference in New York. Hasmik serves on the Advisory Committee of the United Nations University FLORES, the boards of Green Cross France et Territoires and the International Secretariat for Water, as an Ambassador of the Universal Declaration of Humankind Rights (DDHU), member of the EU Water Alliance.

Hasmik holds a Master's in Business Administration from the Université de Nantes, France. She was a U.S. State Department exchange program fellow at the Oregon State Capitol. She was a post-graduate fellow in Environmental management at TU-Dresden, Germany.

#### Bernard Van Nuffel, President of Aqua Publica Europea



Bernard Van Nuffel has been President of VIVAQUA, Brussels' drinking water operator, since February 2019 and of Aqua Publica Europea, the European association of public water operators, since November 2020. Currently Deputy Mayor of Jette, one of Brussels' municipalities, he has been involved in the implementation of local urban and environmental policies since 1997, when he joined the administration of the Belgian capital first with responsibilities for urban planning, then as advisor and chief of cabinet to the Deputy Mayor for Public Spaces. Bernard Van Nuffel is an architect by training.

#### Ewa Ewart, Documentary filmmaker



Ewa Ewart is a journalist and an award-winning filmmaker who specialises in ground-breaking and influential documentaries. Her films have revealed new information about issues such as corruption in Boris Yeltsin's Russia, secret prison camps in North Korea, or the civil war in Colombia. For the last few years, she has been the presenter of an international documentary strand on channels TVN24 and TVN24Bis in Poland. She has also worked for the BBC in London. Her latest documentary work, *Until the Last Drop*, filmed in several locations around the world, explores the global cost and consequences of the destruction of nature and the emerging freshwater crisis. The film has won several awards, including the

special prize of the Prince Rainier III Special Award at the Monte-Carlo Television Festival in June 2023.

He has worked as municipal secretary and in corporate administration, dealing with public works and asset and property management. In 2008 he was appointed general manager of Brianzacque. In 2010 he joined the CAP Group, the public company which manages the integrated water service of the metropolitan city of Milan, one of the biggest single utilities in Italy. He was first General

Manager, then Strategic Development Director; today he holds the position of General Manager of Amiacque, developing new strategies for the company in the areas of waste management and circular economy. He is also General Manager of Alfa, the water company of Varese in Italy.

#### Milena Angelova, Member of the EESC and rapporteur on the Blue Deal



Dr Milena Angelova has been Secretary-General of the Bulgarian Industrial Capital Association (BICA) since 2002. She was Vice-President of the European Economic and Social Committee (EESC) in charge of Budget for the mandate 2018 – 2020. She has been a Member of the EESC since 2007 and Employers' Group Vice-President since 2010. She has been CEEP Executive Vice-President since 2011 and Member of the Euromed Follow-Up Committee since 2020.

As an EESC member working on the EU Blue Deal, she was the

rapporteur of the opinion on Water efficient consumption and consumer awareness about their water footprint (INT/1022) as well as co-rapporteur for the opinion on Water Politics: Between Desertification and Securitization - Time for a Blue Diplomacy (<u>REX/570</u>).

Dr Angelova has been a member of the Bulgarian ESC since 2006 and is well known as an active participant in decision—making processes in Bulgaria, within areas concerning business climate improvement. She has profound expertise in the field of corporate governance, corporate social responsibility, better legislation, SMEs and entrepreneurship promotion, European funds management, skills mismatches and qualified labour shortages. She is senior research fellow at the Institute of Economics of the Bulgarian Academy of Sciences and was a lecturer in the Economic University in Varna. She is the author of more than 45 scientific publications in the area of marketing and of corporate governance.

Almotaz Abadi, Deputy Secretary General for Water, Environment and Blue Economy, Union for the Mediterranean



Since September 2022, Almotaz Abadi has been serving as the UfM Deputy Secretary General responsible for Water, Environment, and Blue Economy. Previously, he held the position of UfM Acting Deputy Secretary General for the same division in 2015-2016. During his tenure at the UfM, Abadi served as the Water Managing Director, leading various initiatives related to water politics; geopolitics; and stakeholder mobilization in the Mediterranean region. Notable achievements include a Ministerial Declaration and the approval of a regional water strategy that focuses on resource efficiency and investment in sectors such as water and renewable energy. With over 20 years of experience, Abadi is an expert in international and regional cooperation. He has worked with various international donor agencies,

organizations, and governments in policy advisory roles. She is the director of the Alliance of Excellence for Research and Innovation on Aeiphoria (AE4RIA). She is chair of the UN Sustainable Development Solutions Network (SDSN)

Global Climate Hub and co-chair of SDSN Europe and is an elected member of Academia Europaea (European Academy of Science), the European Academy of Sciences and Arts, the World Academy of Art and Science, and member of the InterAcademy Partnership Board. In 2022 she received the prestigious European Research Council Synergy Grant and in 2023, she was awarded the Academy of Athens Excellence in Science Award, awarded every four years. She is a member of the Nominating Committee for the Prize in Economics Sciences in Memory of Alfred Nobel.
