Alain Coheur, President of the INT section, European Economic and Social Committee




Alain Coheur is the President of the Section for the Single Market, Production and Consumption of the EESC since October 2020 and was appointed as EESC Group III member by Belgium in 2015. During the previous mandate, he was President of the EESC Temporary Study Group on Social Economy Enterprises and co-spokesperson for the Social Economy Category. During the main part of his career, Alain Coheur was in charge of various positions in the development of social economy organizations. He is currently the Director for European and International Affairs at the Belgian National Union of Socialist Mutual Health Funds (since 2002). In 2013, he was appointed by the European Commission as a member of the consultative multi-stakeholder group on social business (GECES). He was elected President of the Belgian Non-Governmental Organisation "Solsoc" in 2007 and President of the European platform "Social Economy Europe" in 2008.

Hubert Gambs, Deputy Director-General, DG GROW, European Commission







The European Commission is the EU's politically independent executive arm. It is responsible for drawing up proposals for new European legislation, it implements legislative decisions of the European Parliament and the Council of the EU and monitors the application of EU law in the Member States.

Dirk Bergrath, Member, European Economic and Social Committee



Dirk Bergrath is member of the EESC and, among other things, active in the section on the single market (INT). He heads the EU Liaison Office of IG Metall, which with more than 2.2 million members is the largest trade union in Europe. Earlier in his career, engagements with the German Permanent Representation to the EU, the international department of IG Metall and the European Metalworkers' Federation followed his work in research.

Dirk Bergrath holds an MA in International Economics from the University of Sussex (Brighton, UK) and a PhD from RWTH University of Aachen (Germany).

Carlo Calenda, Member of the European Parliament



Carlo Calenda has a Degree in Law with a focus on international law. He has been responsible for product marketing and programming for Sky Italia, responsible for relations with financial institutions and Head of Customer Relationship Management at Ferrari, Director of the International Affairs strategic area in Confindustria. In 2013 he was appointed Deputy Minister of Economic Development and in 2014 given the responsibility for attracting foreign investments. He was a member of the Council of Foreign Trade Ministers, appointed in May 2016 as Minister of Economic Development in the Renzi Government and reappointed in the Gentiloni Government until May 2018. From March to May 2016 he was Permanent Representative of Italy to the EU. He is currently a Member of the European Parliament, active in the ITRE committee, rapporteur on the file on Industrial Strategy. He was also the founder of his political party — Azione.

Judith Kirton-Darling, Deputy General Secretary, IndustriAll



Judith Kirton-Darling is Deputy General Secretary of industriAll Europe, representing manufacturing, mining and energy workers from 38 European countries. She was formerly a Labour Member of the European Parliament for the North East of England (2014-20). Before entering parliament, she was active for 15 years within the Labour and trade union movement, notably she was elected Confederal Secretary at the European Trade Union Confederation in 2011.

Andrea Renda is a Senior Research Fellow and Head of the CEPS Unit on Global Governance, Regulation, Innovation and the Digital Economy (GRID). He is a part-time Professor of Digital Policy at the School of Transnational Governance of the European University Institute in Florence (Italy). Andrea provides regular advice to several institutions, including the European Commission, the European Parliament, the OECD, the World Bank, the Inter-American Development Bank, and many more. He is currently a member of the EU High Level Expert Group on Artificial Intelligence and the advisory group on Economic and Societal Impacts of Research (ESIR), for the European Commission, DG Research and Innovation.

Maria da Graça Carvalho, Member of the European Parliament



Maria da Graça Carvalho is currently a Member of the European Parliament. She is actively engaged in the ITRE, IMCO, FEMM and AIDA committees and is co-chairing the parliamentary intergroup on Long-term, Sustainable Investments and Competitive European Industry. She was a senior advisor of Commissioner for Research, Science and Innovation, Carlos Moedas (2014-2015). As a Member of the European Parliament from 2009 to 2014 she was one of the rapporteurs of Horizon 2020. From 2006 to 2009 she was also Principal Adviser to President Barroso in the fields of science, higher education, innovation, research policy, energy, environment and climate change. She served as Minister of Science and Higher Education of the XV Constitutional Government of Portugal and Minister of Science, Innovation and Higher Education of the XVI Constitutional Government. She is a Full Professor at the Instituto Superior Técnico (University of Lisbon).

Isabelle Schömann, Confederal Secretary, ETUC



Isabelle Schömann was elected as Confederal Secretary in May 2019. Previously, she was a principal adviser to the Regulatory Scrutiny Board of the European Commission providing quality control of all impact assessments and major evaluations by Commission services. From 2005 to 2016, she was a senior researcher with the European Trade Union Institute (ETUI) in Brussels. Isabelle was legal advisor to the European Economic and Social Committee Workers' Group on the European Pillar of Social Rights. She has a postgraduate degree in social and labour law from the Sorbonne in Paris and has authored and co-authored a wide range of studies on trade union issues.

Ben Butters has been with EUROCHAMBRES, the European association of Chambers of Commerce & Industry, since 2008 and was appointed CEO in 2020. Prior to this, he acquired experience in both the European Commission and the European Parliament, as well as working for a network of innovation centres. Directly before joining EUROCHAMBRES, he created and for several years ran his own business providing EU advocacy support to small business associations.



Established in 1958 as a direct response to the creation of the European Economic Community, EUROCHAMBRES acts as the eyes, ears and voice of the chambers and business community. EUROCHAMBRES represents over 20 million businesses in Europe through 45 members (43 national associations of chambers of commerce and industry and two transnational chamber organisations) and a European network of 1700 regional and local chambers. Arthur ten Wolde is the executive director and circular economy expert of Ecopreneur.eu. He previously worked as circular economy policy expert for De Groene Zaak, on sustainability and innovation for a Dutch think tank, where he became coordinator for circular economy and advised AkzoNobel, and on innovation policy for the Confederation of Netherlands Industries and Employers VNO-NCW.
