Ladies and Gentlemen

In crisis situations, just as in normal circumstances, the state can no longer act alone when it comes to making major choices which affect us all. Although the role of public authorities is both essential and impossible to circumvent, state action must be based on a participatory approach as much as on a keener awareness of the importance of social and local democracy.

In the model of governance I seek to apply, I have always tried to promote this commendable approach, which is based on trust, dialogue, partnership and the release of creative energies.

Needless to say, such an approach requires committed actors who are recognized as key players in society, able to serve public interest and work for the sustainable prosperity of their community and their territory.



This is the vision which guides our endeavours for the achievement of harmonious, sustainable development. That same vision prompted the recent establishment of the Economic and Social Council as a constitutional institution destined to serve as a forum for ongoing, responsible social dialogue, for reflection and co-operation, and for making proposals with regard to various economic, social, cultural and environmental issues.

We pin great hopes on the Council to strengthen our institutional set-up, consolidate Moroccan political and social democracy and contribute to the development of our country.

The convening, in Morocco, of this Euro-Mediterranean Summit of Economic and Social Councils and Similar Institutions is an opportunity for us to apprise ourselves of the various national experiences in this regard, and to benefit from such expertise in setting up our Council.

I am convinced this meeting will contribute effectively not only to consolidating the Euro-Mediterranean Project, but also to the promotion of the lofty values underlying it and the formulation of projects which will enable us to address major issues now and in the future.
